Thank you for your request of 13th January 2017 under the Freedom of Information Act 2000 (FOIA) for information in relation to the general questions regarding London Fire Brigade (LFB) Watch Managers (Control).

We have now processed your request and I can confirm we hold the information you have requested.

Please note that some of the information you have requested - the names of the Watch Managers (Control) and those senior to them - relate to third party personal information for a person/s other than yourself and are therefore exempt from disclosure under the s.40 (Personal information) FOIA exemption. However, I can confirm that there are 19 Assistant Operational Manager (as defined in the LFB which is the equivalent of the WMO – Watch Manager Operations). The 19 Assistant Operational Managers (AOMs) are divided into six watches and there are therefore six staff senior to these AOMs at the London Operations Centre. There are also three - Senior Operations Managers and an Assistant Deputy Commissioner who is Head of Service (Operational Response), Tom George.
