There is 1 Watch Manager in Control.

2. Please provide the names of all roles/grades senior to Watch Managers (Control) at both, along with the number of personnel at each role/grade.

The table below provides the hierarchical structure relevant to Control.

*Please note these posts have wider responsibilities than Control.

**The names are not within the public domain and are therefore exempt from disclosure under Section 40 (2) of the Freedom of Information Act 2000. The requested information is the personal data of another individual where the disclosure would breach principle one of the Data Protection Act 1998.

Principle one states;

Personal data shall be processed fairly and lawfully and, in particular, shall not be processed unless –

(a) at least one of the conditions in Schedule 2 is met, and

(b) in the case of sensitive personal data, at least one of the conditions in Schedule 3 is also met.

In considering fairness to the individual's concerned, I have concluded that disclosure would lead to the identification of the individuals and this would not be within their reasonable expectations. Therefore, it is unlikely that such disclosure (constitutes processing) could be considered fair. In addition, none of the conditions within Schedule 2 have been met.


